

Eden Township Board of Trustees Meeting Minutes

May 25, 2015 - 8:00 p.m.

This meeting was called to order in the Eden Community Center by Chairman Ryan Bagent, with all present standing to recite the pledge of allegiance. In addition to Mr. Bagent, the following Eden Township personnel were present; Trustee Don Glover and Fiscal Officer Steve Little. Trustee Ken Hall was absent. Road Maintenance Supervisor Dan Baker came in later. A copy of the minutes, a monthly cash journal report and; fund, appropriation and revenue status reports were given to the trustees. Trustee Glover moved to waive the reading of the minutes, Trustee Bagent seconded the motion and all voted in favor. The minutes were filed for the permanent record.

Public Participation:

There was none.

Old Business:

Trustee Glover reported he had spoken with Licking County Engineer Bill Lozier regarding replacement of culverts larger than 3 feet in diameter. Lozier advised that all request have to be made each year and get on a schedule. If the county has the resources they **may** then help with replacement.

New Business:

Trustee Glover reported the mowing tractor had broken down. There were metal filings in the oil on the dip stick. Trustee Glover further advised this most likely meant a long term break down and that it was time to mow the roads. After some discussion it was decided to seek out a replacement b asking the Licking County Trustees Association to send an e-mail county wide looking for a loaner or if perhaps another township may have a tractor for sale. Also Trustee Glover would contact Southeastern Equipment for a rental, all options that would take time. Trustee Bagent suggested contacting, Quick Mow Inc., the mowing company that was mowing the roads for Licking County. Trustee Glover agreed and made a motion to approve up to \$10,000.00 for a contract with Quick Mow Inc. to mow Eden Township roads for one year and in the meantime continue searching for a tractor and mower. Trustee Bagent seconded the motion and all voted in favor.

Trustee Bagent reported he had complaints and/or questions about road repair by Henry Farley, about Blacksnake Road, Sandy Bagent, about Glover Road and the Licking County Sheriff's Office about Camp Ohio Road. Trustee Glover had also received a question/complaint from Roger Morgan about Baker Road and signage regarding the bridge closure. Fiscal Officer Steve Little reported the Dick Holton made positive comments regarding the appearance of the cemeteries, especially the Miles Cemetery on Stradley Road.

Road Report:

Road Maintenance Supervisor Baker reported advised he would continue working on patching.

Trustee Glover moved to pay the bills, Trustee Bagent seconded the motion and all voted in favor. The attached listing is a true and accurate listing of the bills that were presented to be paid.

Trustee Glover made a motion to adjourn, Trustee Bagent seconded the motion and all Trustees voted in favor. The meeting was adjourned.
