

Eden Township Board of Trustees Meeting Minutes
September 29, 2014 8:00 p.m.

This meeting was called to order in the Eden Community Center by Chairman Kenneth Hall, with all present standing to recite the pledge of allegiance. In addition to Mr. Hall, the following Eden Township personnel were present; Trustees Ryan C. Bagent, Donald L. Glover and Fiscal Officer Steve Little. Road Maintenance Supervisor Dan Baker came in later. A copy of the minutes, a monthly cash journal report and; fund, appropriation and revenue status reports were given to the trustees. Trustee Bagent moved to waive the reading of the minutes, Trustee Glover seconded the motion and all voted in favor. The minutes were filed for the permanent record.

Public Participation:

Township resident Harry Farley was present and asked about the wash boarding roads. His reason for coming to the meeting was to discuss solutions. Salt water, pea gravel, top coating and grading were all discussed. Road Maintenance Supervisor Dan Baker will review the areas of complaint and report back.

Nate Otto, the contractor for the mowing in the township was present and introduced his guest Dana Eash. Dana had recently purchased Nate's mowing business and would be completing the contract year for Mr. Otto in Eden Township. The board acknowledged the sale and that the terms of the contract would be the same but the contract would be re-bid next year.

Old Business:

New Business:

Trustee Glover reported he met with the Licking County Board of Elections regarding improvements/changes/upgrades necessary for the township to have their polling place reopened. Trustee Glover moved to do anything necessary to bring the location up to the Board of Elections standards (see attached) Trustee Bagent seconded the motion and all trustees voted in favor. Trustee Hall reported he had two calls regarding dust and dusty roads. Trustee Bagent reported he had one call on the closed bridge on Baker Road.

Road Report:

Road Maintenance Supervisor Dan Baker reported he was patching holes and had 5-6 days worth of patching left.. He reported continued good comments from Eden Township Residents.

Trustee Bagent moved to pay the bills, Trustee Glover seconded the motion and all voted in favor. The attached listing is a true and accurate listing of the bills that were presented to be paid. The checks and bills were signed and reviewed the next evening due to a computer malfunction.

Trustee Glover made a motion to adjourn, Trustee Bagent seconded the motion and all trustees voted in favor. The meeting was adjourned.
