Trustee Hall moved the adoption of the new health care reimbursement policy suggested by the Licking County Prosecutor's Office, Trustee Glover seconded the motion and all voted in favor.

Road Report: Road Maintenance Supervisor, Dan Baker reported he was going back to the doctor on Wednesday regarding knee surgery. He advised he would report back to work as soon as possible.
