

Eden Township Board of Trustees Meeting Minutes  
November 29, 2010 @ 8:00 p.m.

This meeting was called to order in the Eden Community Center by Chairman Ken Hall, with all present standing to recite the pledge of allegiance. The following Eden Township personnel were also present; Trustee Don Glover, Trustee Ryan Bagent and Fiscal Officer Steve Little. Road Maintenance Supervisor Dan Baker came in later. Eden Township residents Harry Farley, Robin McKee and Amanda McKee from Waste Management were also present. A copy of the minutes, a monthly cash journal report and; fund, appropriation and revenue status reports were given all trustees. Trustee Glover moved to waive the reading of the minutes, Trustee Bagent seconded the motion and all voted in favor. The minutes were filed for the permanent record.

**Public Participation:** Amanda McKee, the route manager for waste management introduced herself and spoke for a few minutes on some of the problems encountered in the Township. After her presentation the board thanked her for stopping in and she left the meeting.

**Old Business:** Don Glover reported we were still in the running for the issue two grant. We most likely won't find out for sure if we get the grant until January. Don also reported the new roof has been installed on the community center.

Ryan reported the generator was set and but we still needed the Energy Co-Op to run the gas line. He also reported the sink in the girls' bathroom had been broken and that we needed more trash cans. Apparently at least one of them has been taken from the Community Center. Harry Farley said that he had some blue barrels that we could use. It was suggested they would be nice in the shelter house.

Dan reported that the toilet in the men's bathroom and one urinal had been broken. All need to be fixed and we will try to find a plumber in the township to repair the items listed above.

**New Business:** Don made a motion to place a replacement fire levy on the ballot in May. Ryan Bagent seconded the motion and after discussion, all members voted aye.

**Road report:** Dan reported several pot holes in wet areas. His plan was to use cold patch if possible to repair those spots.

Trustee Don Glover moved to pay the bills and Trustee Ryan Bagent seconded the motion, all trustees voted in favor. The attached listing is a true and accurate listing of the bills that were presented to be paid.

Trustee Ryan Bagent then made a motion to adjourn, Trustee Don Glover seconded the motion and all trustees voted in favor. The meeting was adjourned.
