

# Eden Township Board of Trustees Meeting Minutes

November 30, 2015 - 8:00 p.m.

This meeting was called to order in the Eden Community Center by Chairman Ryan Bagent, with all present standing to recite the pledge of allegiance. In addition to Mr. Bagent, the following Eden Township personnel were present; Trustee Don Glover and Trustee Ken Hall. Fiscal Officer Steve Little and Road Maintenance Supervisor Dan Baker were not present. Several township residents, including the Sniders, the Hahns, Robin McKee, Harry Farley and a Blacksnake Road resident named Brian. Mary Ann Township representatives Les Wolfe and Captain Randy Miner were also present. A copy of the minutes, a monthly cash journal report and; fund, appropriation and revenue status reports were given to the trustees. Don Glover moved to waive the reading of the minutes Ken Hall seconded the motion all voted in favor, and minutes were filed for the permanent record.

## **Public Participation:**

Tammy Hahn requested minutes of previous meetings and a list was given the trustees. Tammy also reported again the hill on Camp Ohio Road was wash boarded and rough. Harry Farley informed the board that Jeff Bremmer had road grader experience. Brian asked about rough road signs and the trustees responded they would get prices from the county. It was also reported the county load reduction sign was moved at Blacksnake Road and Martinsburg Road.

## **Old Business:**

It was reported the brakes had locked up on the Sterling and that the serpentine belt was being worked on in Mansfield, Ohio. After some discussion Don Glover made a motion to approve and accept the proposed three (3) year contract with Waste Management for residential trash removal in Eden Township. Ken Hall seconded the motion and all voted in favor.

## **New Business:**

Mary Ann Township representatives were present to discuss the fire contract between Eden and Mary Ann Townships. The current contract was for \$32,500 and they wanted a \$10,000 increase to \$42,500 and they would agree to a two year contract (2016 & 2017) at that price. The Mary An representative agreed to go back to their trustees with that proposal and they would get back to the Eden Township Board with their response.

The trustees agreed unanimously to set the Annual Eden Township Organizational Meeting for January 4, 2016 @ 8:00p.m. in the Eden Community Center.

## **Road Report:**

There was none.

Trustee Glover moved to pay the bills, Trustee Hall seconded the motion and all voted in favor. The attached listing is a true and accurate listing of the bills that were presented to be paid.

Trustee Hall made a motion to adjourn, Trustee Glover seconded the motion and all Trustees voted in favor. The meeting was adjourned.
