This meeting was called to order at 8:00 pm, by Chairman Chuck Dunlap, with all present standing to recite the pledge of allegiance. In addition to Mr. Dunlap the following Eden Township personnel were present; Trustee Dave Baker, Trustee Ken Hall, Fiscal Officer Robin McKee and Mike Baker Road Supervisor, Citizens Harry Farley and David McKee A copy of minutes, monthly cash journal, permanent fund appropriations, Super blanket PO#s and revenue status was given to the trustees.

Trustee Hall moved to waive the reading and approved the minutes from the January 25th and organizational meeting Trustee Dunlap seconded the motion.

### Old Business:

The 2021 Eden Township Road project packet was looked over and Fiscal Officer McKee will contact Doug Cottrell to see what steps need taken for advertising for bids. Bid will be accepted 4/26/2021

### New Business:

Mowing contract has expired and needs to be bid, adjustments were made to previous bid packet and will be published for bid opening at the regular meeting 4/26/2021 at 8:05 PM.

Fiscal Officer McKee contacted Doug Cottrell in regards to the amounts generated from a fire/EMS levy and got the following information

3.5 mil replacements levy = \$20,379 annually increase

1.0 mil additional levy = \$29,188 annually

After discussion

Trustee Baker moved a motion to go forward with the 1.0 mil levy for the November ballot, Trustee Hall seconded the motion.

Motion carried Fiscal Officer McKee will contact Doug and begin the process.

Trustee Hall had the owner of a previous sold burial plot want to sell their space to a family member. When this happens the owner or executor of the estate must have a signed and notarized letter to relinquish all rights to the purchaser.

Trustee Baker noted that the International 4900 shot spreader is wore out. Trustee Baker and Mike tore it apart and the pump is no good. Bero will fix if he can or Trustee Baker found a new pump on E-bay for \$297.00. The current state of the spreader is not usable and will also need a new auger. Trustee Baker called and checked prices elsewhere none were cheaper than the E-bay.

Trustee Hall moved a motion to purchase a new pump, Trustee Dunlap seconded the motion.

Motion carried. Fiscal Officer McKee will set up an E-bay account and find out what needs done to file tax exempt.

Fiscal Officer McKee presented the Trustees with the overlook for the insurance policy renewal for 2021. With all in agreement that everything was good Fiscal Officer McKee signed and will email back to Reinhart Insurance.

Trustee Baker said Loren with Licking County mentioned that the county would like to purchase the Durapatcher, and wanted to know when it was last used. Trustee Hall explained that the Township paid approximately \$66,000.00 for the Durapatcher new and we can purchase tar from the City of Newark and would only need a shoot in the tailgate of the truck to utilize the Durapatcher. All Trustees agree they are not wanting to sell the Durapatcher at this time.

Water is backed up on Houdeshell at the culvert and we may need to call the Army Corps of Engineers.

#### Road Report:

A property owner on Harmon Road East would like their culvert replaced-1<sup>st</sup> place on the right off of Rocky Fork Road

We need new cutting edges for the drag, ordered from Dexter  
The elevator needs inspected.

We need 57 & 411 limestone. Trustees Baker will order 60 ton or 57 and 40 ton of 411

The culvert check on the roads for 2021 road project has not been done yet.

Playground is getting weedy already.

Trustee Hall moved a motion to pay bills. Trustee Dunlap seconded the motion.
