All trustees have agreed that the Township Hall will now be available for rent again, with the change of the rental price changing from \$65.00 per day to \$80.00 per.

All accounts for state deposits have finally been updated and the PNC account can be closed.

Fiscal Officer McKee received back the Resolution paperwork from the County for the Fire/EMS levy for the 2021 ballot.

Resolution 2021-03 was voted on by the board.

Some of the mowing we are getting billed for is still not getting done according to Mike Baker. I deduct whatever mowing he reports have not been done prior to paying the bill for the month.

New Business:

Trustee Baker was contacted by Wayne Claggett to see if we could come pump out his brine tank (he has a pump on site).

Fire/EMS has been paid for the 1st half of 2021.

Trustee Baker received the quote back from Mid-Ohio Paving for Chip & Seal on Tarlton Road, Blacksnake Road East and West and Baker Road South. Asphalt patching on Baker South at Rainrock Road, Blacksnake Road at Martinsburg Road and Swick-Holton Road at Rainrock Road. The prep on Blacksnake East on the hill in front of Harry Farleys house would be completed by the township with asphalt to smooth the area prior to Chip & Seal. Mid-Ohio would use .4 RS2 emulsions and 22 lbs of #8 limestone to double chip the aforementioned areas.

A tree came down on Houdeshell Road between Delancy and Bero, Trustee Baker went over and cleaned it up.

Road Report:

The mowing is almost finished.

Mike has not received any complaints about the roads since the last meeting.

Trustee Baker moved a motion to pay bills. Trustee Hall seconded the motion.
