This meeting was called to order at 8:00 pm, by Chairman Chuck Dunlap, with all present standing to recite the pledge of allegiance. In addition to Mr. Dunlap the following Eden Township personnel were present; Trustee Dave Baker, Trustee Ken Hall, Fiscal Officer Robin McKee, Mike Baker Road Supervisor, Citizen Harry Farley, Bill Felumlee, and representatives from Newton and MaryAnn Township fire departments. A copy of minutes, monthly cash journal, permanent fund appropriations, and revenue status was given to the trustees.

Trustee Hall moved to waive the reading and approved the minutes from the October 25th meeting Trustee Baker seconded the motion.

Public Participation:

MaryAnn Townships new fire introduced herself and let the board of trustees know that they were not making any changes to the pricing for the new contract with the townships. She also presented the board with the runs for Eden Township for 2021 through October. Chief Smith with Newton Township agreed that they were not planning any changes and also presented runs for Eden Township for 2021 through October. Trustee Hall said he had not heard of any complaints about performance for either fire department and the board will await contracts to move a motion to renew for 2 more years.

Old Business:

Austin Lecklider with the prosecutors office has filed the paperwork for the quick title for the Myers property. If no one files complaints we should close January 26th, 2022. At that time the 3 parcels will become 10298 Purity Road.

ARP funds- Fiscal Officer McKee sent pictures to Carolyn that she sent on to Ken Ozwalt for further evaluation on the doors and the playground. Trustee Baker will follow up with ken for more guidance.

Elevator- Still have not heard back from ACME in regards to repairs. Trustee Baker will try to get some other numbers so the repairs can be taken care of.

New Business:

2022 debt schedule is filed.

Notice was received from Ohio Division of Liquor Control in reference to Bartmart filing for a license for the old Purity Market. After discussion the trustees will not request a hearing, Trustee Baker moved a motion to accept the notice, seconded by Trustee Dunlap.

They would like for him to come to a meeting and speak to them about exact location.

Rhonda Neighbarger would like to replace headstones in the cemetery for her family members, Trustee Hall explained that she may do so if she likes. She is wanting to make sure she is in the correct area since some of the stones are no longer legible.

Trustee Hall asked who will take over the cemetery duties after 12/31/2021, Trustees Baker & Dunlap would like for newly elected Leonard Laughman to take on that task, Trustee Hall said he would be happy to show him what to do.

Co-Alliance will be put on a routed plan for the propane, Trustee Baker will contact the office to make the arrangements.

Bonds need ordered for Baker and Laughman, Fiscal Officer McKee will contact Reinhart and get them.

Road Report:

Trustee Baker ordered a turn signal for the International truck.

Trustee Baker is hoping to get the springs on the F550 installed this week.

Mike reported he has been filling holes on Baker North.

The brine tank is full

Road signage is needed because stock is low, Mike will call and order some signs for stock.

Backhoe is back and running good.

Bane-Welker was out and tore apart the tractor-waiting for parts- Mike will call them and get a progress report.
