This meeting was called to order at 6:30 pm, by Chairman Dave Baker, with all present standing to recite the pledge of allegiance. In addition to Mr. Baker the following Eden Township personnel were present; Trustee Chuck Dunlap, Trustee Leonard Laughman, Fiscal Officer Robin McKee, Mike Baker Road Maintenance, Citizen Harry Farley, Bill Felumlee, Bart Wilson, Vic Yarnelli and Newton Twp. Fire Dept. representatives. A copy of minutes, monthly cash journal, permanent fund appropriations, and revenue status was given to the trustees.

Trustee Dunlap moved to waive the reading and approved the minutes from the February 28th meeting Trustee Baker seconded the motion.

### Public Participation:

Bill Felumlee wanted to thank the trustees and Mike for the work they have done on the roads.

Newton Township fire department presented the runs for the month of March. 4 runs were made for Eden Township.

Trustee Baker reminded the Newton Township representatives that when a road has road closed signs they are not to travel that road. They asked that we notify them when roads are closed and they will distribute emails to all people on hand.

Bart Wilson (owner of Bart Mart) asked the trustees if he was able to put a storage shed behind the store. Trustee Baker has spoken with the insurance company and they have notified him that they would not have a problem with Mr. Wilson putting a building that close to our building and if something were to happen and it catch fire they would then in turn go after his insurance company for payment of damages to our property.

Mr. Wilson also asked why we do not have a recycling dumpster in our township. Trustee Baker let him know that we had one before but people were using it to dispose of things other than recycle products and it was removed.

All trustees are fine with Mr. Wilson getting a shed.

Mr. Yarnelli asked when we are going to get Baker Road fixed. Trustee Baker explained that we have approximately \$80,000-\$100,000.00 per year for all roads and that we are trying to find grants to help get the roads fixed.

Mr. Farley asked if we had heard anything from Tom with the Conservation Club about them holding hunting safety classes as they had asked. Mr. Baker replied that no one had heard from Tom so we are assuming the no longer need to use the building.

#### Old Business:

New locks and keys are finished.

Porta John has been ordered and will be here on April 1<sup>st</sup>.

Claggett returned the signed mowing contract for the 2022 season-copies were given to each trustee for their file.

Trustee Laughman has cleaned up some of the things at the cemetery and will contact Mr. Hall to see when he was removing everything for the year so that he can get that taken care of. Harry Farley requested that we review the rules and make changes needed and post the rules at the cemetery for everyone to see.

ARP \$ ideas need to be discussed at the April meeting as the first report is due by April 31<sup>st</sup>. Trustee Baker said we definitely need to replace the front doors.

The elevator is now in working order but due to the length it was down the State now would like to do a weight test, once that is done we will be turned back on.

The circuit board for the siren at the township garage has been taken out for repairs and will be reinstalled quickly so it can be fully operational.

Trustee Dunlap is going to check on the progress of the engineers estimates for the roads that he had turned in.

#### New Business:

Gary with Rinehart Insurance will attend the April meeting to discuss renewal.

#### Road Report:

Mike has been working on patching holes in the chip & seal roads with cold mix twice a week. Stickle Road is already falling apart.

We are needing 57, 411 & 4 limestone.

The salt water truck needs break lines, Trustee Baker will fix if Mike will get the needed materials.

Steve Nethers has a 1000-gallon plastic tank he said we could try out and see if it works for what we need. Trustee Baker asked him for a price on it but has not yet gotten an answer.

Trustee Dunlap moved a motion to pay bills. Trustee Baker seconded the motion.
