A copy of minutes, monthly cash journal, permanent fund appropriations, and revenue status was given to the trustees.

## Public Participation:

#### Old Business:

Trustee Baker mentioned maybe we should look at putting a key drop in the new front doors for the rental key to be returned without problem.

Fiscal Officer McKee revised the rental agreement for the township hall, all trustees agree that the changes are what they were wanting.

The playground has been removed and is roped off. Waste Management brought a dumpster for all the equipment removal at no charge to the township.

Trustee Baker will cut off the end of the culvert at the Parish residence.

### New Business:

Trustee Baker asked Hysong Tree Service to give the township a quote for removing a few tree branches at the cemetery on Stradley Rd, the quote came in at \$600.00.

Trustee Dunlap moved a motion to move forward with the removal at a cost no larger than \$1000.00 in case of any incidentals. Trustee Baker seconded the motion.

The flag pole is broken at the top and will need a bucket truck for repair or we could take the old flag pole out and install a flag pole on the building for easier access. Mr. Farley will pick us up a couple of flags from the veteran's office.

Road work for 2022—Fiscal Officer McKee will contact the Prosecutors office to find out if we can get a bid packet and will run ads for bid opening during the June 2022 meeting.

Fiscal Officer McKee contacted Martin Trucking to see if they had received the March check because it had not yet been cashed. Dayna said they had not gotten it. Check 11844 will be voided and replaced.
