This meeting was called to order at 6:30 pm, by Chairman Dave Baker, with all present standing to recite the pledge of allegiance. In addition to Mr. Baker the following Eden Township personnel were present; Trustee Chuck Dunlap, Trustee Leonard Laughman, Fiscal Officer Robin McKee, Mike Baker Road Maintenance, Citizen Harry Farley, Ashely Baker and Hunter Baker with Newton Twp Fire Dept., Keisha Amspaugh and Jacob Castle with MaryAnn Twp Fire Dept., Larry Finkes

Trustee Baker moved to waive the reading and approved the minutes from the June 27th meeting

Public Participation:

Newton Twp Fire Dept. presented runs for 2022, 24% being fire runs and 76% being medical. Newton Twp and MaryAnn Twp Fire Departments asked for donations at \$400.00 each to purchase products for the kids at the elementary school for Fire Prevention. Both stations brought examples of the items they would like to purchase to hand out to the children.

Explaining that these items help bring up fire prevention and conversation at home.

Hughes on Tarlton would like his hydrant fixed if possible, the Martinsburg Road owner would like theirs removed if it is not in working order.

The tractor had blown a tire and Bob's Tire Service patched it to get it back to the shop, two tires were replaced once there. The 550 also got 2 new tires.

Batteries are needed for the grader and the international.

All scrap tires are now gone.

Scott with Southeastern is trying to figure out what is wrong with the backhoe, could be an axillary pump. Hopefully will hear from him this week and someone can come take a look at it.

Someone tore the flag and flag pole off the front of the building and left it laying in the front yard. Trustee Baker said it was there in the AM on Sunday and Mike found it in the AM on Monday laying in the yard. All pieces were still there, he will hang it higher so it can not be reached from the ground.

Road Report:

The stop sign is gone at the intersection of Tarlton and Blacksnake Roads.

Roads are washed out again due to the storms and culverts are full.

Mike had purchased fuel and no receipt would print so they are supposed to email to Robin.
