Public Participation:

Mr. Boyce with Toboso Agg introduced himself and presented the board with pricing and was sure to let them know he would be willing to negotiate pricing for large quantities of stone. All stone is washed and has been inspected and waiting for the state certified stamp of approval. They offer a berm mix that local townships are using that consist of #4 stone down to a sand/clay mixture for \$10.00 per ton picked up at their site. The plant has the ability to produce 150-200 ton per hour so there is plenty of product on hand at all times. At this time, they do not have ability to haul but assured the board he would be able to find owner/operators willing to deliver. They do accept credit cards or we could set up an account to be paid on 30-day terms, Fiscal Officer McKee asked Danny to please send the township a credit application.

Old Business:

Harmon West oversize project is complete.

Old computers can not be donated as they are password protected by previous fiscal officers and the current fiscal officer cannot open to be sure that all township information is deleted.

The brakes for the f-550 have been purchased and will be installed.

Austin Lecklider has spoken to the County Engineers office in regards to Jeff Cottrell, he believes that the Engineers Office may go out and look at the property.

New Business:

Trustee Dunlap damaged the passenger rear fender on the f-550 while plowing snow, they are trying to find a replacement.

Trustee Baker had a citizen of the township contact him in regards to being buried on his property upon his death. Trustee baker contacted the Prosecutors office and was told that with no zoning within the township a property owner can be buried on their property but would suggest a headstone to mark the grave and that it would be necessary to note on the death certificate where the body is located.
