This meeting was called to order at 6:30 pm, by Chairman Dave Baker, with all present standing to recite the pledge of allegiance. In addition to Mr. Baker the following Eden Township personnel were present; Trustee Chuck Dunlap, Trustee Leonard Laughman, Fiscal Officer Robin McKee, Mike Baker Road Maintenance, Citizens Larry and Erin Finkes, Harry Farley and Eric Landis.

Trustee Baker moved to waive the reading and approved the minutes from the January 30th, 2023 meeting Trustee Dunlap seconded the motion.

Public Participation:

Larry Finkes explained that Licking County Engineers Department told him that the driveway they wish to replace the culvert in was never permitted. They are currently waiting for the County to let them know if they can replace the culvert. Larry explained the driveway has been there for 50+ years. They were also informed that if bigger than a 12" culvert is needed they may have to go with galvanized or concrete.

Eric Landis is concerned about Baker Road South where the asphalt meets the chip & seal, there is a substantial dip that needs to be leveled out. Trustee Baker said we may be able to fix with the dura-patcher once we have liquid. Until then they may try some 411 limestone. Trustee Baker asked Mike to take over some 411.

Harry Farley asked if the trust CD for the cemetery could be usesd to purchase a mower if the township does not find anyone to contract with for the 2023 mowing season. Trustee Baker has spoken with some people in regards to mowing and has gotten one quote for \$1020.00 per week for everything. He is also talking with Mowtivated Mowers to get a quote from them. He was also thinking of talking to Bladensburg and see who mows their cemetery.

Old Business:

Gary Myers is having a hard time with getting the grader apart, unsure how far and how much money to spend on the repairs Trustee Baker suggested they move motion to set a limit.

Trustee Baker moved a motion to set a \$3,500.00 limit for repairs to the grader. Trustee Laughman seconded the motion.

New Business:

Fiscal Officer McKee received the insurance renewal paperwork from Rinehart and presented it to the trustee for them to look over.

The old playground equipment and the trailer that was sold needs to be removed and the new playground equipment needs added. Fiscal Officer McKee will make the changes and return to Rinehart by the March 30th due date.

Trustee Dunlap submitted paperwork to the Engineers office to get estimates for Baker Road North. Willey Road, Painter Run Road and Boodle Road for 2.5" of compacted asphalt.

The county is going to bring concrete block to set up and area for them to store cold patch.
