Fiscal Officer McKee will contact the prosecutor's office to get a bid packet put together for the trustees to look over for the April meeting.

The tailgate on the F550 has been fixed to accommodate the use of the durapatcher.

Trustee Dunlap moved motion to pay from the ARP fund the 7 days of lost work for Mike during his time off after testing positive for Covid. Robin will contact Amy to see if we are allowed to use ARP funds to pay for that time.
