This meeting was called to order at 6:30 pm, by Chairman Dave Baker, with all present standing to recite the pledge of allegiance. In addition to Mr. Baker the following Eden Township personnel were present; Trustee Charles Dunlap, Fiscal Officer Robin McKee, Trustee Leonard Laughman was out for personal reasons. Citizens, Bill Felumlee, Larry Finkes, Harry Farley representatives of Waste Management and Shackelford Disposal and Josh Amspaugh of the MaryAnn Twp Fire Dept..

Trustee Dunlap moved to waive the reading and approved the minutes from the September 30th, 2024 meeting. Trustee Baker seconded the motion.

Bid Openings for Waste Removal:

Fiscal Officer McKee opened and read out loud both bids that were submitted.

Shackelford Disposal

Regular rate \$22.50 per month to include 1 trash tote

Senior rate \$20.25 per month to include 1 trash tote

Additional totes \$7.00 per month

Waste Management

Regular rate \$18.28 (2025), \$19.01 (2026), \$19.77 (2027)

Senior rate \$16.47 (2025), \$17.13 (2026), \$17.81 (2027)

Trustee Dunlap moved motion to accept the bid from Waste Management, Trustee Baler seconded the motion.

Fiscal Officer McKee had the trustees sign the contract and gave it to the representative from Waste Management for signatures, he will return to her by email.

Harry Farley asked if the representatives speak to the drivers, and wanted to know why the totes are no longer placed back in the driveways or the yards and are often left in the roadway. They replied they will speak with the drivers and be sure they are always placed out of the way.

Public Participation:

Josh with MaryAnn Twp Fire Dept presented the board with runs and schedule, and wanted to make sure everything was good.

It has been a busy month with fire prevention.

The Fire Dept was awarded a grant for 7 complete ballistic vest, front and rear plates, helmets and carry bags.

Their 1st annual car show went well, followed by trunk or treat.

They have now mapped out all driveways in Eden Township that are greater than 1000ft and they have been flagged in the CAD system.

3-4 new spots have been marked for landing.

They will be flushing dry hydrants in the area on November 1st.

Harry Farley added that he like that we are now seeing the numbers each month and asked if they are soft or hard billing. Josh replied they are soft billing and if anyone should get a bill they are to trash it, they are accepting what the insurance is paying.

Old Business:

Harmon Rd and Swick-Holton Rd issues have been fixed

Still waiting on the county for dry hydrant information and right of way maps.

New Business:

Trustee Baker said we are out of gravel and need to order more. He tried getting some last week but Martin was too busy to bring, hopefully this week we can get some. The last of it was used on Glover Rd.

Poly for the snow plow will cost around \$750.00 10' long x 10" wide x 1" thick.

2 new tires were put on the 4300, it is in need of king pins very soon.

Robin said she would find the number for the service guy Chapin uses on Garfield Ave.

Trustee Baker said he would also talk to the guy with Rescue Wrench.

The case tractor needs the front tires replaced, it has been 3-4 years since they have been done.

Mow-tivated mowers called and wanted to know if they should be done with the season. Trustee Dunlap said that is a good idea.

Rex Stevenson invited the trustees to attend their meeting tonight about banning wind and solar power in the townships. The Ohio Farmers Bureau would be there to discuss the process.

Trustee Baker told him our meeting was at the same time so they could not attend.
