This meeting was called to order at 6:30 pm, by Chairman Chuck Dunlap, with all present standing to recite the pledge of allegiance. In addition to Mr. Dunlap the following Eden Township personnel were present; Trustee Dave Baker, Trustee Leonard Laughman, Fiscal Officer Robin McKee, Citizens Larry & Erin Finkes, Harry Farley, Bill Felumlee and Jeff Posey & Brandon Turner of the Newton Twp Fire Department

Trustee Dunlap moved to waive the reading and approved the minutes from the September 25th, 2023 meeting Trustee Baker seconded the motion.

## Public Participation:

Brandon Turner introduced himself as t

he assistant chief of the Newton Twp Fire Dept and explained that the contract for fire and EMS services will expire on 12/31/2023 and they would like to ask for an additional \$10,000.00 per department (\$10,000.00 for Newton and another \$10,000.00 for MaryAnn) to renew the contract for another 2 years, to expire on 12/31/2025. At that rate the twp would be paying \$55,000.00 per year to each department. Fiscal Officer McKee explained that at the end of the two years we would no longer have the funds to pay at that rate.

Mr. Turner said that with our current levies we should be able to afford the increase. Fiscal Officer McKee explained that one levy is ongoing but the other expires, with the increase in everyone property taxes it is very unlikely that anyone is going to vote on another levy to increase their taxes even more. Without the expiring levy we will not be able to afford a \$20,000.00 per year increase.

Trustee Dunlap asked if they would be willing to accept a \$5,000.00 per department increase for the time being. Mr. Turner said they would discuss it with their Fiscal Officer and would attend the December meeting. Mr. Posey said that they have lost employees due to other departments paying higher wages therefore they have had to increase wages, and the cost of equipment is a lot higher than it has been in past years. They have gotten 2.5 million in grants over the past 5 years that have helped tremendously. They currently have a new fire engine on order and a new medic

on order. Fiscal Officer McKee asked if they had used ARPA funds to help pay for the ordered equipment which Mr. Posey responded yes but did not give the amount of government funds from ARPA had been used.

Mr. Turner noted the increases as follows

26.9% increase of calls

63.6% increase of hourly wages

34.9% increase for maintenance

21% increase on supplies

40% increase overall

In 2021 Eden Twp runs were 63, 2022 runs were 65 and so far for 2023 68 runs.

Trustee Baker asked if they knew how much money was left on the table due to not pursuing unpaid bills. Neither knew the amount but acknowledge there is money that is not collected.

Trustee Baker also asked if they knew who was in charge of the dry hydrants in Eden Twp, he has received calls from 2 residents who would like them taken out because they are not maintained and are now filled with sludge. They will check with the Newton Twp Fiscal Officer and see if she knows. Mr. Turner said he will also check with Chief Smith to see if he knows who is responsible for the dry hydrants.

At that time Mr. Posey and Mr. Turner were given the check for the 2<sup>nd</sup> half of 2023 and excused themselves from the meeting.

Mr. Felumlee asked again when Stradley Rd would be mowed, he had asked at the last meeting and was told there were only 6 roads left but Stradley has still not been touched.

Trustee Baker replied that Mike is on vacation and he believes that Stradley and Houdeshell Roads are the only two left to finish up this year.

Fiscal Officer McKee will run an ad in the Newark Advocate the third week of December.

Fiscal Officer McKee let the board know that the remaining ARPA funds needs to been obligated to project by 12/31/2023.

A 2013 backhoe was purchased for \$56,500.00 from the ARPA fund. The backhoe discussed at the October meeting had already been purchased but he found another with only 2190 hours. They had went and looked at it and decided it would be a good purchase for the twp. Trustee Baker said we should be able to make adjustments to the buckets we currently have to fit this one, the tires are also interchangeable.

Mr. Felumlee asked if we had a better contact than Southeastern to maintain the new backhoe. Trustee Baker said he had tried several places with the issues with the other one so he is not sure of who else they would be able to depend on for service.

Fiscal Officer McKee said she has received an email that we again have a new attorney representing us- Bryce Ramsay is now in charge of Eden Twp and we can contact him with any concerns.

The backhoe has been added to the insurance policy.

The mileage has been received from the county and they are showing Eden Twp at 26.303 miles, no changes from the previous year.

We have also received another email from Amy before she left that Jeff Cottrell had sent a letter wanting to know what the township is going to do with the 4" tile running into the ditch in front of his house. Trustee Baker needs to get some pictures and send to Bryce. Cottrell would like a concrete basin installed and for us to extend the ditch past his property line. He also sent receipts for all the culvert pipes he had purchased.
