This meeting was called to order at 6:30 pm, by Chairman Dave Baker, with all present standing to recite the pledge of allegiance. In addition to Mr. Baker the following Eden Township personnel were present; Trustee Leonard Laughman, Fiscal Officer Robin McKee was absent this meeting, Citizen Jackie Laughman sat in to take minutes Citizens, Bill Felumlee, Diana Hall, MaryAnn Twp Fire Department (Keisha Ampaugh and Ethan Barker), Erin and Larry Finkes and Harry Farley.

Trustee Dunlap moved to waive the reading and approved the minutes from the May 20th, 2024 meeting. Trustee Baker seconded the motion.

Public Participation:

Diana Hall presented the trustees with a written proposal for the purchase of the property the block building sits on.

Trustee Dunlap explained that the township has to discuss this with the prosecuting attorney. Trustee Baker will give the proposal to the prosecutor.

Diana explained the building would remain until a new building is built. Also explained how Intel is going to change the township since we have no zoning, they are still wanting to do things the right way even without zoning in place. The store will not become a retail store and will remain a small store as it is now.

Captain Ampaugh reported the runs YTD, states CPR training is done at camps. Water training and new recruits by life guards to show training

EMS runs were discussed, they have the 911 center ready to change, due to legal requirements a letter must be sent to them to give consent to change. Robin will send email to them, (Robin was not notified to send email, Keisha sent copy of contract and all is good)

Harry Farley asked if equipment is on private property and gets damaged is it the property owners responsibility, and is it the owners responsibility to be sure fire and ems can get down their driveway.

All trustees signed the contract and presented to Captain Amspaugh to get signed and return one copy to Robin for our records.

Old Business:

Radiator-returned, now to be fixed

Dry hydrants-Dave had Gene Maharg come in. We as the township own none of the bridges, because of this we cannot bolt hydrants or anything to a bridge, bridges belong to the county. The Commissioner would have to approve use of the bridges. Hydrants could cause damage to property, the commissioner is concerned with the pipes.

Trustee Baker explained how it works and that there is no weight added to the bridge structure 100 thousand gallons of water can legally be drawn from the water flow. There are more water points than what ponds provide for the township and would be less expensive to maintain.

Captain Amspaugh said Belmont County has done this and would recommend. They can reach out to them if we would like.

Bill Felumlee suggested we present ourselves to the Licking County Commissioner with the Fire Dept. and explain it would help the citizens of this community and help to keep them safe.

Trustee Baker explained he can and will install the hydrants ourselves.

MaryAnn Fire Dept. will be checking this week to see which hydrants flow. They had a fire on Hickman Rd Sunday and if they had bridge hydrants it would have helped.

Trustee Baker and Captain Amspaugh explained how easy they are to install.

Mid-Ohio is charging \$66,000.00 to rent equipment and labor which is under the \$75,000.00 and we have more control over the cost by doing it this way. We will know exactly how much stone and oil are used. 700 ton 8 gravel and 400 ton 57 gravel
